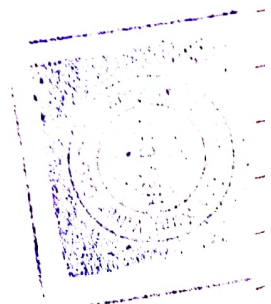
Minutes of the Special General Body Meeting of the Kunj Vihar CGHS Ltd held on dated 25/03/2018 at 4:00 PM in the society premises.

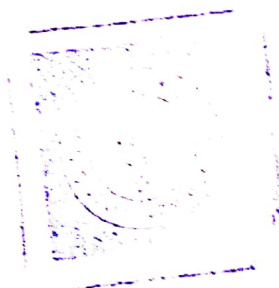

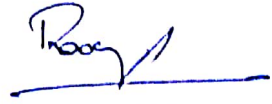

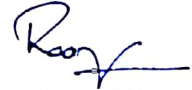
