## COMMENTS ON THE BALANCE SHEET ITEMS

#### <u>LIABILITIES SIDE :-</u> <u>SHARE MONEY (Rs.5,91,300/-)</u>

The balance under this head of account as on 31-03-2009 is Rs.5,91,300/- as compared to the balance of Rs.5,52,900/- as on 31-03-2008. During the year 2004-05 a sum Rs.19,100,00 has been transferred to sundry deposits of the member account whose membership has been ceased and payments were in dispute. Further three members have been expelled and a sum of Rs.19,300/- has been transferred to payment due to expelled members in the year 2005-2006 and payments were in dispute. During the year 2008-2009 above disputes have been settled & those four members are re-enrolled, therefore a sum of Rs.38400 is received.

#### Contribution from members (Rs.32,44,99,922.00) Reserve car parking (Rs.31,29,550.00)

The balance under this head on account of contributor from members as on 31-03-2009 was Rs.32,44,99,922.00 as compared to the balance of Rs.30,74,90,912 as on 31-03-2008. The total contribution received from the membership during the year is Rs.1,70,09,010.00.

#### Sundry Deposit (Rs.7,80,000.00/-)

The sum of Rs.15,60,100.00 is payable to the members namely S/Sh. Vivek Pathak (ceased) and Vikas Mittal (transferred from his ledger A/c to Sundry Deposit account by previous M.C.) whose membership has been ceased and payment were in dispute as on 31-03-2008. During the year as per RCS order restored the membership of Sh. Vivek Pathak & transferred a sum of Rs.7,61,000.00 to Contribution from Members and Rs.19,100.00 the share capital account.

### Sundry Creditors (Rs.2,62,25,199.50/-)

The above said balance reflects the amount payable to the suppliers and contractors (mainly to previous contractor M/s Techno construction Rs.10231560.50 & M/s Hi-Tech Construction Rs.1,56,71,139.00/-) of the society and also includes the amount payable to the persons who has made payment in advance for membership in the society but due to some reasons in the application and on their personal request the membership could not be granted to them and amount payable to ex-members. Sundry Creditors also includes Rs.99968.00 being TDS & VAT payable at the end of the year. There was dispute between M/s Techno Construction & Society, & a compromise held between them.





Settlement agreement states that both parties have agreed to compromise all disputes and upon execution of the agreement, the society shall pay a sum of Rs.2,00,00,000.00/- against all liabilities of Techno Construction. The said amount will be paid partly by transferring FDR for Rs.80,00,000/- along with interest accrued of Rs.1768439.50 & balance of Rs.1,02,31,560.50. The list of Sundry Creditors is enclosed herewith.

#### Expenses Payable (Rs.71130.00/-)

The above said expenses payable at the end of the year relate to audit fees and other expenses.

#### **Earnest Money**

The balance under the head earnest money as on 31-03-2009 is Rs.50,000.00 as against the balance of Rs.1,00,000.00 at time of last audit. During the year Rs.50,000.00 adjusted in Techno Construction.

#### Retention securities (Rs.450000/-)
