**5. DISPUTED CLAIMS**

There is disputed claim with the contractors of the society and dispute between the previous Managing Committee members of the society.

**6. RECONCILIATION**

The society periodically reconciles its accounts with the bank but not with the members at the close of the cooperative year. However the society is forwarding the statement of accounts to individual members for confirmation.

**7. AUDIT COMMENTS**

Comments on items stated in Balance Sheet and Income Expenditure accounts are given separately and appended to the report.

**8. RECORDS**

Certificate of custodian of records and cash certificate are enclosed with this report.

**9. FIXED ASSETS**

Society is periodically reviewing its Fixed Assets.

**10. LOANS**

The society has not granted any loan, hence this clause is not applicable to the society.

**LIABILITIES SIDE :-**

**Share Money (Rs. 5,90,700/-)**

The balance under this head of account as on 31-03-2012 is Rs .5,90,700/-.

**Contribution from Members (Rs.47,90,55,273.50)**

The balance under this head on account of contributor from members as on 31-03-2012 is Rs.47,90,55,273.50 as compared to the balance of Rs.40,71,64,370.50 as on 31-03-2011. The total contribution received from the membership during the year is Rs. 7,18,90,903.00.

**Sundry Creditors (Rs. 1,63,40,803/-)**

The above said balance reflects the amount payable to the suppliers and contractors (mainly to previous contractor M/s Hi-Tech Construction Rs.1,56,71,139.00/-) of the society. The matter with M/s Hi-Tech Construction is in dispute and is sub-judice wherein M/s Hi-Tech Construction has claimed a sum of Rs. 4 Crore and the same is contested by the society.

**Expenses Payable (Rs. 2,78,385.00)**

The above said expenses payable at the end of the year relate to audit fees and other expenses.

**Earnest Money**

The balance under the head earnest money as on 31-03-2012 is Rs.50,000.00 as against the balance of Rs.50,000.00 at time of last audit.

**Retention Securities (Rs. 41,57,970/-)**

The closing balance under this head of account was Rs. 28,95,680/- as on 31-3-2011. During the year Rs. 12,62,290/- are retained from the contractors.
